## CAA Position Statement on OTC devices and Sound Amplifying Products

This position statement represents the Canadian Academy of Audiology's (CAA) position on a particular topic or area of practice. It provides a time-limited viewpoint that will be reviewed and revised as necessary when and if new information becomes available. ### **Position:**

In the past several years, the US Food and Drug Administration (FDA) finalized legislation creating a category of Over-The-Counter (OTC) devices (Federal Register, 2022). These medically regulated devices are subject to regulations designed to address safety and reasonable quality, and to address the communication issues arising for those people with mild to moderate sensorineural hearing loss in adults.
